

Minutes May 30, 2017

The City of Langdon Place held its regular monthly meeting at the John Knox Presbyterian Church. Mayor Frank called the meeting to order at 7:00 p.m.

Present at the meeting: Mayor Mike Frank, Commissioners Kathleen Snyder, Aaron Hardy, Scott Scinta, Attorney Stan Chauvin III and City clerk/Treasurer Theresa O'Bryan.

Guest attending the meeting: None

Absent from the meeting: Charlie O'Bryan

The minutes from the April meeting were read. Council member Hardy made a motion to accept the minutes as read. Council member Scinta seconded it. It passed in favor of accepting the minutes 4/0.

Old Business: Phil Shafer of Integrity Properties finished the mulching of the trees. Some of the residents were not in favor of the brown cypress mulch. The council decided to advise the residents that the city gets a bulk rate on the mulch and the city wants the trees in the easement to have a uniform look.

Mayor Frank said the Judge has not ruled yet on the Mayor Gregg Fisher lawsuit regarding City of Louisville taking over the sanitation contracts. He also noted that 55 of the small cities are fighting this issue and have put funds toward covering the legal fees for this case.

Hardy advised that Miller Mowing Company hasn't submitted a bid yet for the leaf removal.

It was suggested to put a note about the next Junk Day pickup in the upcoming newsletter. It was also suggested that Mayor Mike contact Rumpke and remind them about that date since there was some confusion about the last junk day date.

New Business: Councilmember Snyder advised that resident Kathleen Gilman asked her if the Council thought it would be OK if the "View" funds could be used to pay attorney fees accrued thus far. Mrs. Gilman also wanted the City to be aware that they may be seeking another attorney to handle the case if it reopens. The Council wanted Gilman to know that while it supports the decision, the Council cannot advise on this issues.

Bob Ray is injecting the trees for the ash bore. They have also taken down the blue ribbons after they injected the trees. They have put up green ribbons for the trees that need to be taken down soon. There were a total of 170 ash trees originally planted in the neighborhood.

Hardy said there were exposed wires in the back of a resident's property. They suspect the wires are from Cable Company. The resident doesn't have cable at their home. Mayor Mike and Hardy will go and try to find out which home has those wires and then they will call the company to have them come out and bury the lines.

Mayor Frank said that Officer White is not serving in our district anymore. Lieutenant Joseph Webb and Officer David Hamblin are now in charge of our district. There number is 502-574-7920. Mayor Mike has asked Officer David to attend our June meeting. He is only allowed to enforce ordinances that the City of Louisville has in place.

Attorney Chauvin presented the City with the Citation Officer Ordinance. The city had the first reading of this ordinance.

Finance Report: The monthly bill report was presented to the council for review. Council member Snyder made a motion to approve the bills and Council member Scinta seconded it. It passed 4/0 in favor.

Treasurer O'Bryan read the first reading of the budget ordinance 1 and 2 for the fiscal year beginning July 01, 2017.

O'Bryan presented the audit bid from Bechtler, Parker & Watts for the year end 2017 finances. Hardy made a motion to accept the bid and Scinta seconded it. It passed 4/0 in favor,

Beautification Report: Duggins to continue to paint the street poles in the neighborhood. The company was able to assist David Tapp in installing the 6 mailboxes.

Street Lights: Scinta will be ordering new signs for the Yard of the month and the junk day trash pickup for the next year.
