Mayor Mike Frank began the meeting with the Pledge of Allegiance.

The minutes from the July 25, 2023 meeting were read. Council member Charlie O'Bryan made a motion to accept the minutes as read. Council member Scott Scinta seconded the motion. It passed in favor of accepting the minutes 5/0.

Mayor Frank suggested that we have LMPD target speeders on Blossom from Titleist Road to Langdon Drive due to the increase speeding on those streets.

- Working on getting a street light analysis done for our city.
- Eight Division has reported crime has trended downward in the last few weeks.
- Officer Hamblin is on an injury leave.
- Vehicle parked and blocking view on Blossom Ln/Langdon Dr. Ordinance Officer David Mudd contacted the individual

The Council has received these various complaints:

- Residents need to grind down their stumps after removing trees in their yards.
- Dirt silt is running down sloped yards and pooling in the streets after heavy rains.
- Drainage hoses that are visibly seen on property.
- Grass is not being mowed in a timely fashion.
- Camper parked in driveway.

Attorney Chauvin will look into these complaints and review if any ordinances need to be updated. He will instruct Ordinance Officer David Mudd to also go and visit the homeowners to inquire about ways to alleviate the issues.

Attorney Chauvin reminded the council that if a non-city owned tree falls down and lands across a city street, the city will clear the tree to the property line. The homeowner will be responsible for cutting down the remainder of the tree as well as grinding the stump.

Finance Report: The monthly bill report was presented to the Council for review. Council member Scott Scinta made a motion to approve the bills and Council member Yolanda Demeree seconded it. It passed in favor of acceptance 5/0.
